- All submissions for Phase 1 must be registered online <u>here</u> by 11:59PM on Monday, 15 April 2024.
- Submission must be an original creation. Original creation means it has been created directly and personally by the participant(s). Direct copying or imitating another person's work is not considered an original submission.
- If PacificLight has reason to believe that a submission is not original, evidence may be requested from the participant. Any submission that is not considered original in nature will be rejected and disqualified from the Competition.
- It is the legal responsibility of the participant(s), not PacificLight, to ensure compliance with all ownership and copyright requirements to reproduce any images, drawings or visual representations used.
